ENHANCE YOUR REWARDS: Infinity Bonus

Earn down each leg to the next Partner who holds the same Rank or higher as you do.

As you advance in Rank, you earn more Infinity Bonuses.

For example, as a Visionary Director, you can earn 1% down to the next Director, plus 1% down to the next Innovator Director, plus 1% down to the next Visionary Director.

IMPORTANT TERMS & DEFINITIONS

- 1) **Member:** a subscriber to the LEV/AI platform.
- 2) **Partner:** an independent contractor who may refer Members and other Partners to represent LEV/AI and earn in the Compensation Plan. To remain a Partner, you must pay your annual Partner License. You may be repositioned to Member status if you go six (6) months without an active subscription for yourself or at least one (1) personally referred Member.
- 3) **Personally Referred:** is any Partner or Member who designated you as their referring (or enrolling) Partner when they created their account.
- 4) **Commission Periods:** at LEV/AI, you are paid either weekly or monthly, depending on the bonus:
 - 1) **Weekly Pay:** you will be paid for Acquisition Bonuses & Subscription Commission on personally-referred Partners & Members on a weekly pay cycle running Monday to Sunday. Your payout will typically be available on Thursday of the following week, though it may be impacted by holidays.
 - 2) **Monthly Pay:** you will be paid for all other Commissions & bonuses based on your performance in each calendar month. You should receive your compensation payment for each calendar month by the 10th of the following month.
- 5) **Acquisition Bonus:** Earned for personally referred (enrolled) Partners and Members. 50% total first months' earnings include the 30% Acquisition Bonus + 20% commission on personally referred subscribers. All Partners are eligible for the Acquisition Bonus regardless of Rank.
- 6) **Leg:** is like a branch in your organization chart. It begins with a personal referral or "frontline" Partner and includes everyone they refer, and everyone those people refer, and so on. Your Legs must be Personally Referred in order to count toward your Rank requirements.
- 7) **Volume in Each Leg:** is the total of sales for all Partners and Members in each Leg, in USD for US-based Partners or USD equivalent points for international Partners. *Important note about leg volume beginning January 1, 2026:* 51% of the volume in each leg must come from Members.
- 8) **Active Members:** are Members who have paid for a new or recurring subscription in the Commission Period. Please note that these Members may select any LEV/AI subscription. Personally referred Partners do not count toward this qualification criteria.
- 9) **Levels:** a "Level" is formed by a referral relationship. For example, if you refer Kelly, she is on your Level 1. If Kelly refers Mike, he is on your Level 2, and so forth. All Partners are eligible to earn Level 1 Commissions, for their personal referrals, regardless of Rank.
- 10) **Dynamic Compression:** removes Partners and Members from your referral tree each month. If a Partner or Member has no activity, they are "skipped" for purposes of calculating your LEV/AI Commissions, and the remainder of your team will be moved up to their place.
- 11) **Personal Referral Tree:** follows relationships of referral, without considering compression or any other changes in your team organization.

All compensation is based on net subscription fees. Net subscription fees do not include sales tax, VAT, Partner License or other fees. Any refunds or failed payments will reduce volume and commissions.

Important Note: LEV/AI cannot promise or guarantee a given level of income regarding earning additional income or any other earnings opportunity. The success or failure of each LEV/AI Partner, like any other business opportunity, depends on your own skills and personal effort.
